## WEBSITE RELOCATION

Due to an extraordinarily liberal interpretation of the judgment against us, the General Conference's attorneys have succeeded in convincing several internet service providers and domain registrars to hand over or terminate the services of most of our websites and domain names—regardless of who had registered them.

As a result, we have been forced to relocate our website servers to outside of the United States jurisdiction to avoid further loss of time and content. The content remains unaffected by the switch from the user's perspective, however the address is now **[www.thefourthangel.net](http://www.thefourthangel.net)**. Should some unforeseen persecution be brought against this non-United States site for its "infringing content" of the Advent Gospel, please access **[www.csda-adventistchurch.to](http://www.csda-adventistchurch.to)** for a fully functioning mirror well outside of U.S. jurisdiction until service is restored.

## LANHAM ACT PETITION

The petition is still active at [www.LanhamAct.us](http://www.LanhamAct.us) to amend the law currently allowing religious observances to be regulated by Federal trade law. As we have long stated in many of our writings, the union of religious observances with the civil power is not only anathema to the founding principles of our nation, it is an abomination to Yahweh and is the very essence of the foundation of Papal rule.
